## Lap Swim Rules and Guidelines

1. Do not enter the pool if a lifeguard is not present.
2. Lap swimmers must abide by the posted rules and lifeguard direction.
3. Participants must bring their current pass to lap swim each time and check in with the lifeguard on duty.
4. Participants must adhere to all additional guidelines as directed by the lifeguard(s) on duty.
5. Circle pattern is required if all lanes already have two swimmers. Lifeguards may ask you to change lanes to better accommodate swimmers being grouped according to speed.
6. The lifeguard is not allowed to watch your children or personal property.
7. Please use the restrooms which are adjacent to the pool.
8. The Pool Office is restricted to City of Seal Beach employees only.
9. No diving.
10. No foul language.
11. \$10 for lost pass replacement
12. The City of Seal Beach reserves the right to revoke lap swim passes for noncompliance of pool rules or Lifeguard direction.

## Release and Indemnification

I fully understand that my (or my child's) participation in the above activity exposes me (or my child) to the risk of personal injury, death, communicable diseases, illnesses, viruses, or property damage. I hereby acknowledge that I am voluntarily participating in this event/class and agree to assume any such risks. I hereby release, discharge and agree not to sue the City of Seal Beach, its officers, employees, agents and volunteers, for any injury, death or damage to or loss of personal property arising out of, or in connection with, my (or my child's) participation in the event/class from whatever cause, including the active or passive negligence of the City of Seal Beach, its officers, employees, agents and volunteers or any other participants in the event/class. In case of emergency, I give my permission for emergency medical treatment. The parties to this AGREEMENT understand that this document is not intended to release any party from any act or omission of "gross negligence," as that term is used in applicable case law and/or statutory provision. In consideration for being permitted to participate in the event/class, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless City of Seal Beach, its officers, employees, agents and volunteers from any and all claims, demands actions or suits arising out of or in connection with my participation in the event/class. I also give my permission to the City of Seal Beach to photograph me or my child participating in this event or activity for advertising purposes for the City of Seal Beach and acknowledge I will not receive any compensation for such use.
